New Fund Covers Costs of sponsoring up to 1,000 refugees identified by the United Nations Refugee Agency (UNHCR)!

The University of Ottawa Refugee Hub and the Shapiro Foundation, together with Jewish Family Services Ottawa, have announced the creation of a new fund to facilitate the sponsorship of up to 1,000 refugees identified by the UNHCR.

For a limited time, qualifying Canadian groups will have the cost of sponsoring a refugee through the Blended Visa Office Referred (BVOR) program fully covered by the fund. Funding for both start-up costs and settlement costs associated with BVOR sponsorship will be available to groups that submit applications to the fund before September 17, 2018, or until the fund is exhausted prior to the deadline. Refugees sponsored with the support of this fund will arrive in Canada before December 31, 2018.

The Blended Visa Office-Referred (BVOR) Program

A Cost-Sharing Program!

The BVOR Program is designed to resettle refugees identified by the United Nations High Commissioner for Refugees (UNHCR) who have been approved by the Canadian government.

The refugee/refugee family sponsored through the BVOR program will arrive within 6 to 12 weeks of their application approval and the Canadian government will share half of the sponsorship costs with sponsors.

The refugees resettled under the BVOR Program receive income support from the Government of Canada through the Resettlement Assistance Program (RAP) for 6 months after their arrival (during months 2-7). Private sponsors offer another 6 months of financial support (during months 1 and 8-12) plus the startup costs.

What are the sponsor's settlement responsibilities?

- **Reception** at the airport (refugees are not taken to the Reception Centre);
- Housing & basic necessities (this is covered for 6 months through RAP income support, but sponsors cover start-up costs);
- Settlement assistance (including language classes, enrollment in school, finding health care provider, job search, etc.), and
- Emotional & moral support.

Who can Sponsor under the BVOR Program?

To sponsor refugees under this program, you must be a:

- Sponsorship Agreement Holder (SAH) or Constituent Group (a group that can sponsor refugees under a SAH agreement);
- Group of Five; or a
- Community Sponsor.

Refugee populations in the BVOR program include:

- Syrian, Iraqi, Iranian
- Congolese, Ethiopian, Eritrean
- Somali, Colombian, Sudanese

Particular vulnerabilities or reasons for resettlement:

- Women and girls at risk
- LGBTQ2
- Survivors of violence and torture
- Lack of foreseeable alternative durable solutions

They have friends living in Toronto, ON, and it is recommended that the family resettles in the same community. The family would appreciate the assistance of a sponsor in their resettlement to Canada.
